I hope you all had a merry Christmas and a great New Year! The school yearis off and running. January is a long month and with the weather we have, it has made it seem longer. Please remember that it is cold, and with the freezing temperatures, have your students wear adequate clothes to school. On February 6th, we are celebrating Loomis's first Academic Awards Recognition Night. Each year, students around Nebraska, Kindergarten through 11th grade takes a "Measure of Academic Progress test" (MAPS) that focuses on reading, math and science. Students in grades 3rd through 10th take a test called the Nebraska Student-Centered Assessment System known as the NSCAS
test. Juniors in high school take the ACT. These are rigorous tests that assess the knowledge gained from year to year. Loomis will be honoring the kids that met the following criteria for those tests last spring. We will be honoring the kindergarten through the senior class members. Loomis will also be honoring the students that had perfect attendance for the first semester of this year.

Top 25\% on the MAP math assessment
Top 25\% on the MAP reading assessment
Top 25\% on the MAP science assessment
Exceeded Standards on the Nebraska State math assessment (3rd- 10th) Exceeded Standards on the Nebraska State reading assessment (3rd - 10th)
Exceeded Standards on the Nebraska State science assessment (5th, 8th) ACT (Juniors only)

## Perfect Attendance

We will be honoring all $K$ through 6th grade students at the half time of the girl's game and all 7th through 12th grade students at the half time of the boy's game on the 6th of February against Axtell. I am very proud to say that 116 students met 1 or more of the criteria to be honored. This is an incredible accomplishment. While the test scores were from last spring, this fall and winter, we currently have 257 students' Kindergarten through 12th grade. This comes out to $45 \%$ of the current $K-12$ student body.
