# From the Wolf's Den

Oh, the dreaded snow and ice season! Maybe the toughest part of the job being a Superintendent is making that call to have school or not to have school. Let me assure you, I always take the safety of our students and staff into consideration when making a snow day decision. Many of our students and staff drive at least 10 miles to school here in Loomis; some more than 10 and obviously some less than 10 miles.

Information I receive in helping make the decision to go, or not to go includes; webinars posted by NWS in Hastings, local forecasts, NTV Weather, The Weather Channel, etc. I drive the roads early in the morning, both highways and country roads, and depend on local people who I call and find out what the driving surface is like. Finally there is typically a chain text between nearby school superintendents. However, that is not always the deciding factor based on different locations getting different amounts of moisture. When in doubt it is easier to call a 10:00 start, and change to all day. A ten o'clock start at least gives our students and staff daylight to see the roadway.

Preparing the school for an open day of classes is often times very difficult. Our custodians consider snow removal as "all hands on deck" to open the parking lot, clear the sidewalks, and make sure all entries are operational. They do an awesome job taking care of the outside perimeter when moving snow and salting icy surfaces. Our school cooks and bus drivers are also notified as soon as a concrete decision is made.

With all the precautions we take to ensure the safety the staff, students and patrons, there are still some precautions that should be followed. Slow down and drive cautiously to allow you adequate time to make decisions based on the traffic. Walking slowly in lit areas so ice can be detected after re-freezing occurs. Always checking and double-checking around the large piles of snow on the campus for on-coming traffic and pedestrians.

Just remember, please slow down, take your time and get to your destination safely. I believe I heard today we are 56 days from spring!!

I hope you all had a great Holiday break. January is a long month and with cold temperatures and snow. Please make sure your students are wearing coats, pants, a warm hat, and gloves to school. If the feels like is below 20 degrees, we will have indoor recess. They will need snow boots to be able to walk in the snow in the chance that we go outside. Loomis will also be honoring the students that had perfect attendance for the first semester of this year. LPS had 5 students that did not miss a day first semester with perfect attendance. This is a huge accomplishment when you factor in sickness, family trips, appointments, or anything else that make pull students away from school.

LPS will be honoring all K through 6<sup>th</sup> grade students at the half time of the girl's game and all 7<sup>th</sup> through 12<sup>th</sup> grade students at the half time of the boy's game on the 24th of January against Franklin.

It seems that we are in the thick of the cold and flu season. Please monitor your students for sickness. If they are sick, please keep them home. If they are on medication to reduce fever, please keep them home. Students need to be fever free for 24 hours before returning to school. This is important in many ways. With the substitute teacher shortage, we want to keep our staff healthy. Students are participating in many activities, and we want them all to be as healthy as possible. We are continuing to disinfect and wipe down classrooms, hallways, and buses to help reduce the spread of sickness. Please do your part to help us out.

We try to keep all details updated on the school calendar. If there are questions, please call the school and we will do our best to keep you informed.



#### Axtell Triangular and Burwell Invite

The Loomis-Bertrand wrestling team began their January schedule with a triangular facing host Axtell and Hi-Line. Up first for the Wolfkings was what turned out to be a very tight battle with the Bulls. It was a gritty team performance as the Wolfkings took the 42-39 victory. Several matches could have been considered to be the key to the team win. Phillip Titkemeier got a come from behind win at 126 and then the Wolfkings did some bumping up in weight that paid off with key wins from Tryston Edwards and Cauy Meyer to help ensure the team stayed on top in the end. Against Axtell the Wolfkings got out to an early lead with open wins in the lighter weights. Axtell closed the gap in the upper weights but a big pin by Caden Swanson wrestling up at heavyweight ensured a 45-36 win for Loomis-Bertrand.

The following day the team traveled to Burwell for their 20 team Invite. The Wolfkings were down a starter or two but those filling in provided solid points as others stepped up to increase their production. This allowed for a solid 5th place team finish just 13 points short of 3rd place East Butler. Team Champions Crofton/Bloomfield (199) edged St. Paul (196.5) as they both distanced themselves from the field.

Individually the Wolfkings were led by Freshman Tyson Freeman as he secured the first individual championship for the team this season going 4-0 with 3 pins and a major on his way to the title at 113 lbs. Senior Kellan Brown remained solid and steady contributing a 3rd place finish at 132 with 3 pins. Junior Clay Bohr medaled once again as 2 pins and an overtime win advanced him to a 3rd place finish. Sophomore Carter Horner took the next step and put himself on the medal stand at 120 lbs with a 4th place finish due to hitting the 5 match limit after battling through the consolation bracket and not getting to wrestle in the medal round. A Freshman fivesome came up short of the medals but put wins up to keep the team near the top. At 220 Walter Kenney finished 3-2, at 126 Phillip Titkemeier finished 2-2, Cauy Meyer was 2-2 at 160, Caden Swanson would go 2-2 at 285 lbs, and Dylan Wendell went 1-2 at 106 lbs.

#### **SEM Invite**

The Wolfkings were without both of their Senior wrestlers at Sumner but found themselves in the 5th spot in the team race once again at the SEM Invite. The team scored 105 points and were a half a point behind Axtell in 4th place. Anselmo-Merna took third with 146, Kearney Gold edged them for Runner-up honors with 149, and Amherst controlled the top spot with 194.5 points.

Clay Bohr (Jr.) was the lone championship bracket finalist for the Wolfkings as he would finish runnerup at 152 lbs with 3 pins on day. A trio of freshman all brought home 3rd place medals from SEM. Tyson Freeman went 3-1 on the day to take 3rd at 113 lbs. At 160 lbs Cauy Meyer lost his first match but then pinned 4 straight to earn his first medal of the season. Caden Swanson put together a 4-1 day with 4 pins in the 285 bracket to take home his first medal getting 3rd place as well. Carter Horner had a great performance in the consolation side of his bracket as he beat 4 opponents that had plus .500 records only to hit his 5 match limit and be left with a

fourth place medal. Phillip Titkemeier (126) and Walter Kenney (220) also put up a couple of wins each but came up short of the medal round.

### **RPAC Tournament**

Southwest was the host for this year's RPAC Tournament. The Wolfkings managed to bring home a new team high 8 medalists and finished 4th in the team standings with 108 points. Hitchcock County took the Conference Championship followed by Cambridge and then Southern Valley.

Clay Bohr came home with the 152 lb RPAC Conference Championship as he pinned his way through the bracket! At 120 Carter Horner didn't have to worry about the 5 match limit this time as he put himself in the finals. He finished runner-up after losing a narrow 2-3 decision. Caden Swanson kept himself rolling with a 2nd place finish having gone 3-1 on the day against the heavyweights. Phillip Titkemeier made good on earning his first medal at 126 with a 2-2 performance. Kash Schoff lost his first match but a pair of wins on the back side of the bracket earned him a 3rd place medal as well. Tyson Freeman added another medal with a 4th place finish at 113 lbs. Cauv Mever made it two medals in a row with a 4th place finish this week at 160. Walter Kenney also made good on getting his first medal of the season with a 4th place at 220. Dylan Wendell added a win at 106 lbs but was a match short of earning a medal.

The FFA chapter has been very busy so far this year and we wanted to share all that we have done. We began the year with volunteering. On August 22th the FFA chapter helped the community by picking up trash off of the road. We walked highway 23 between Loomis and Bertrand and filled many garbage bags with litter. The chapter got the privilege to attend Husker Harvest Days on September 14th. There were very informative booths throughout the area. The students also completed a scavenger hunt by finding different booths and completing different tasks.

Leah Schutz, Marie Ford, Reece Vinzant and Lane Schoff were all able to compete at State Range Judging near Chadron in September. Out of 168 individuals Leah got 59th, Marie got 107th, Reece got 109th, and Lane for 132nd. The team placed 20th out of 42 teams.

BerMis hosted a livestock judging contest at Cross Diamond Cattle Company on October 8th. There were around 13 different towns with about 100 different competitors. In the junior division, Marie Ford placed 1st, Dylan Wendall placed 4th, Tyson Freeman placed 8th, and Clydie Kegley placed 10th. The junior team placed 1st overall. The chapter gave back to the community on October 8th also by putting on a farmer feed. We served pulled pork sandwiches, beans, salad, chips and a dessert. We had an excellent turn out from all our local farmers.

The chapter was able to make an appearance at the Bertrand Craft Show on October 15th. The FFA Alumni hosted a baked good booth filled with items donated by the member's parents. The students also helped vendors set up and pick up.

Ten students were able to attend the National State Convention in Indianapolis, IN, on November 26-29th. The students got to listen to many incredible speakers as well as volunteer around Indianapolis. Bethany Pelton had the opportunity to participate in the National FFA Choir and was able to sing at all of the gatherings.

The chapter also had their first team compete at National FFA this year! Drake Hermanson, Johanna Ford, Lane Schoff, and Leah Schutz competed in the Environmental and Natural Resources competition. They completed a virtual portion, which consisted of a written test, identification, and data interpretation. They then went to a pumpkin patch near Indianapolis and completed the soils, GPS, and water quality portions of the evengt. Lastly, they did a team presentation on the effects that wildfires have on residential recreation. Each team member earned a silver rating, and they earned a silver rating as a team.

The chapter had a meeting on November 7th with a guest speaker. Our speaker was Brandon Rimpley who is an agronomist at Norders near Elwood. Brandon told us about his job, what he does, and answered any questions we had.

November 9th many students participated in Career Development Events at Curtis. CDEs included natural resources, agriscience, and livestock judging. In agriscience blue ribbons were awarded to Shelby Schoene and August Nelson. A white ribbon was given to Dylan Wendall. The team placed 5th overall. In natural resources Gracianna Wilcox got a blue ribbon. Red ribbons were given to Sydney Harris, Logan Schutz, Marie Ford, Allyson Schoff, Coleman Langford, Carly Stewart, and Marcia Estrada. Reece Vinzant and Bethany Pelton both received white ribbons. The team placed 2nd overall and qualified for state. Junior livestock judging included a purple ribbon to Garrett Scholz and blue ribbons to Ella Brown, August Nelson, Addison Andersen, and Marie Ford. Red ribbons were awarded to Katelyn Evans, Shelby Schoene, and Dylan Wendell. The team placed 4th place overall and qualified for state. In senior livestock judging Colton Wagner got a blue ribbon, Marcia Estrada got a white ribbon, and the team placed 7th overall.

December 5th chapter members went to the Bertrand Nursing Home to sing for the residents to spread Christmas joy.
